Mr. William WONG Yee Lai is the son of Dr. Allan WONG Chi Yun, the Chairman and Group Chief Executive Officer of the Company. Mr. William WONG Yee Lai is deemed to be interested in 74,101,153 shares of the Company by virtue of his being one of the discretionary beneficiaries of The Allan Wong 2011 Trust, which is a discretionary trust of which Dr. Allan WONG Chi Yun was the founder, for the purpose of Part XV of the Securities and Futures Ordinance. The details of The Allan Wong 2011 Trust are set out in the Company's 2019 Annual Report.
