At the annual general meeting (the "2015 AGM") of VTech Holdings Limited (the "Company") held on 15 July 2015, a poll was demanded by the Chairman for voting on all proposed resolutions as set out in the notice of the 2015 AGM of the Company dated 10 June 2015.

As a majority of the votes were cast in favour of each of the following resolutions, all such resolutions were passed as ordinary resolutions and the poll results are set out as follows:-

As at the date of the 2015 AGM, the total number of issued shares of the Company (the “Shares”) was 251,182,133 ordinary shares of US\$0.05 each, which was the total number of Shares entitling the holders thereof (the “Shareholders”) to attend and vote for or against all the resolutions proposed at the 2015 AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the 2015 AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and there were no Shareholders that were required under the Listing Rules to abstain from voting. There were no restrictions on any Shareholders to cast votes on any of the proposed resolutions at the 2015 AGM.

Computershare Hong Kong Investor Services Limited, the share registrar of the Company in Hong Kong, acted as the scrutineer for the purpose of vote-taking at the 2015 AGM.
